

RELEASE AND INDEMNIFICATION AGREEMENT

Please read carefully before signing as this agreement affects your legal rights.

I, the undersigned, in consideration of being allowed to participate and permission to participate in Cheyenne Little Theatre Players, In., productions, events and activities, of any type or kind. Whether as a volunteer, actor, director, cast member, stage crew member, technical crew member, or in other type or kind of position or capacity (hereinafter "Participant") and other good and valuable consideration, on behalf of myself, and my heirs, executors, administrators, guardians, and all others, do hereby fully and forever release and discharge the Cheyenne Little Theatre Players, Inc., it's officers, directors, cast members, stage crew members, technical crew members, and all other participants, of and from all claims, demands, debts, causes of action, damages, injuries, costs, expenses, and any and all other claims of damage or causes of action whatsoever, both in law and in equity, on account of, arising out of, or in any way resulting from or related to personal injuries, pain and suffering, death, property loss or damage arising out of, related to, or growing out of Cheyenne Little Theatre Players, Inc., productions, events and activities. This agreement applies to claims or causes of action including but not limited to negligence, strict liability, warranty (whether express or implied), but does not apply to willful and wanton misconduct.

I hereby expressly state, agree and contract to indemnify and hold harmless the Cheyenne Little Theatre Players, Inc., and those persons referred to in paragraph one above, of and from any and all actions, causes of action, claims, demands, or damages whatsoever or whenever arising, asserted by myself, on my behalf, by my parents, or by my estate or any other person.

I do further expressly state, agree and contract that if I am under the age of 18 years of age I sign the RELEASE AND INDEMNIFICATION AGREEMENT as my own free act and further, that the signature of one of my parents, as natural and legal guardians and next friend appears hereon and this agreement shall be binding on myself and the above referenced persons. AS UNDERSIGNED PARENT OF A MINOR CHILD/PARTICIPANT, AND AS NATURAL AND LEGAL GUARDIAN AND NEXT FRIEND, I EXPRESSLY STATE, AGREE AND CONTRACT TO BE BOUND BY THE THERMS, CONDITIONS AND PROMISES OF THE RELEASE AND INDEMNIFICATION AGREEMENT AND DO RELEASE, HOLD HARMLESS, AND WILL INDEMNIFY THE ABOVE RELEASED CHEYENNE LITTLE THEATRE PLAYERS, INC., AND PERSONS REFERRED TO ABOVE ACCORDING TO ALL TERMS OF THIS AGREEMENT.

The terms of this RELEASE AND INDEMNIFICATION AGREEMENT are contractual and not a mere recital and contains the entire agreement between the parties hereto. This RELEASE AND INDEMNIFICATION AGREEMENT shall be governed by the laws of the state of Wyoming.
